General members and Charter members have voting rights and may hold office; Associate, Charter Associate, Affiliate, and Honorary members do not have voting rights and may not hold office.

**Form 990, Part VI, Line 11b - Form 990 Review Process**

The 990 is reviewed in detail by the organization's Executive Director, Treasurer and Finance Committee members. It is then provided to all members of the board for review and discussion prior to filing with the IRS.

**Form 990, Part VI, Line 12c - Explanation of Monitoring and Enforcement of Conflicts**

Prior to taking office, all elected or appointed Directors must sign Conflict of Interest Disclosure Form. This form is retained by the Office and discloses all
